#### REPORT FROM HEADQUARTERS:

This month many of us have been absorbed in establishing a school for the children. It is at the request of the children that we do this, and for that reason it has been a pleasant and easy job. Last year, a small class operated the whole winter in the Village school room (65 Scott #1). It was this first experience which gave us enough knowledge with which to proceed into this year. Today the Family Home School System includes about 50 children. Preschool is in the homes of participating parents. They hope to eventually find a permanent place for the preschool, where equipment can be kept and where the children will have plenty of room to play. Kindergarden is in the Village school room four mornings a week - the fifth day there is a field trip. We want to develop a physical education program for the kindergarden in the future.

Primary school operates in two sessions. Each session uses the school room all afternoon for one week; the next week classes are held in family homes and workshops. Advanced students receive special tutoring. This way the children have one week of concentrated academics in the school room and one week of elected subjects with their favorite family specialists. The subjects elected thus far are French, geography, sewing, cooking, carpentry, theater, exercise and roller skating. Stephanie Hiller and Eddie Lepler are our dedicated full time teachers. They work without salary, but they have requested that we pay \$25 per child initially, and \$15 per month per child afterwards, to make it possible to buy classroom and athletic equipment.



At the end of the first week we feel very successful. The children and teachers are pleased. We had our first Parent-Teachers Association meeting to choose a Board of Directors, so that we can incorporate and become legal. Father will be our spiritual advisor. Pam Letourneau will be our first President of the Board of Education, Judy Kovalaskie Vice President, Carolyn Cugini Treasurer, Anna Lynn Dayton Secretary. Yamuna will be Kindergaden Representative, Connie Autori Preschool Representative, and Anna Lynn and Judy will double as Representatives for the Primary School.

We have decided to give the children the education they want and need, free from the traumas of public education as it exists today. The first week's observation has revealed some wonderful insights. As our story develops, we will report the true life experiences of Siva Kalpa education.



#### EDITOR'S REPORT:

This issue marks the beginning of our second year of publication. With over 300 copies distributed monthly, both at home and abroad, the newsletter has apparently become a Siva Kalpa institution. Encouragement for continued publication has been surprisingly strong, so we proceed with Volume II, hoping you all enjoy it. Also, those who haven't already, are requested to please renew their subscriptions so that funds for printing and mailing, as well as occasional office expenses, will be covered. Since our press date seems to fluctuate each month, we are expanding the calendar to one and a half-months this time. 


















#### CLUNY, FRANCE \* Sept. 27, 13th Year \* TONY AUTORI

#### Dear Fellow Members of the State Bar:

I would like to direct your attention to the two front page articles in your April/May 1978 copy of "Reports". They give a preview of the State Bar of California's 51st annual meeting taking place in San Francisco the week of September 8-13. The articles state that approximately 5,000 lawyers and judges will assemble to discuss and debate some 235 tough issues dealing with legal matters, as well as moral, social, and political considerations.

This year's conference resolutions are contained in a book weighing close to four pounds. There is a resolution which would put a law student on the Board of Governors of the State Bar and pay each Board member \$50.00 a day up to \$500.00 a month for the conduct of State Bar business. Another would raise the jurisdiction of small claims court to \$2,000.00 and would permit both parties to appeal. There is a resolution to permit the sale of beer and wine to persons 18 years and over. And another which asks the State Bar to support an economic boycott of non-ERA states.

This letter is not written as a criticism of any of the resolutions, or the delegates and lawyers who will be in attendance at the annual meeting to debate them and vote on them.

Instead, it is to voice my concern over the widening gap betweeen the original premise of law and lawyering, and law as it is now being developed and practiced.

Why do we, as lawyers, keep getting involved in more and more complications? And, more importantly, why does public respect for lawyers decline with each passing annual meeting even though we have proposed four pounds of resolutions to improve the manner in which we perform our duties?

Based on my experience of 18 years of successfully practicing law I suggest it is because we have forgotten the basic purpose of law and the role of the lawyer.

The purpose of law is protective and corrective. It is to maintain peace and order at any given period of time, and therefore, must be responsive to changes in society's needs.

In order to maintain a happy peaceful population each person must feel that the legal system will treat him justly. Let us search for ways to improve the representation of all people regardless of their financial conditions rather than condemn the efforts of those attorneys who are trying to provide such services.

The newadvertising rules could include information dispensed by the State Bar to inform the public of their individual rights as well as their obligations to others.

As lawyers we must use our time and energy to solve the problems of court congestion. We must suggest alternative methods of settling disputes such as neighborhood justice centers and arbitration system.

We should take the time to listen to our young people who have many questions about the legal system today particularly with regard to prosecution for the use of certain drugs which have not been proven to be any more harmful than the legal drugs nicotine and alcohol. We might begin by supporting drug research as well as drug education classes in schools and prisons.

And let us not lose sight of the real role of a lawyer as arbitrator, peacemaker, and protector. A lawyer's responsibility is to bring parties to a point of agreement. Whether the lawyer is handling a business dispute, a family matter or a criminal action he must serve society as a protector of the relationships and the self respect of the parties.

Now is the time to question the adversary system as it is being practiced today. In a system where one party wins, the other party must lose. In order to win, some lawyers are acquiesing to clients who can afford to buy justice by using distorted facts and delay tactics. Others, particularly in family law, use the emotional insecurities of the parties to divide relationships, even where there are children who are the products of those relationships, in order to gain an unfair advantage for the client.

Lawyers who win, whatever their methods, are rewarded with big fees and reputations. We must think of resolutions which will make it as profitable in terms of money and prestige for the lawyers to bring about agreement between parties as it now is to cause dissension.

I strongly urge that you do not disregard the contents of this letter. And that you take time to meditate on these issues.

# RECIPES

Gree

Ghee Candy

It is easiest to make ghee in a wok. Melt 1# sweet butter (unsalted) over a medium flame, stirring constantly. When it starts to boil, reduce heat slightly and continue stirring. Ghee is ready when the milk solids (tiny white particles) start to turn gold. Use a stirring spoon in which you can see the color of the particles easily. Remove from heat immediately. Strain through a thin cotton cloth. Save the cooked solids for making gnee candy.

For this amount of solids use a half gallon of milk. Wipe the wok clean with your straining cloth. Bring milk to boil and reduce to simmer. Stir constantly until milk reaches the consistency of cream (about 45 minutes). Stir in milk solids from the ghee. Simmer stirring about 5 minutes and stir in 1 1/2 C white sugar. Continue stirring over low flame until thick. Cool and form into 3/4" balls.

Eggplant-Tomato Juice Curry for 4

Cut I large eggplant in 1" slices and then halves. Cut I large eggplant in I slices and then halves. Keep in water for a half hour or so then drain for 5 minutes on dish towel. Pulverize 1 chopped onion in blender (add 1/4 C water to facilitate blender action). Mash a 1" piece of ginger (this can be done with a garlic press). Fry eggplant pieces with lots of oil until golden Reserve. In 1/4 C with lots of oil until golden. Reserve. gnee over low heat fry piece of stick cinnamon, 3 cloves and 1 crushed cardamon pod. When spices In 1/4 C start to brown, add onion; when onion starts to turn golden, add ginger. Stir, then add 1 C tomato juice and 1/2 t salt, turneric, 1/4 t cayenne. Add eggplant and simmer covered for 5 minutes. Remove cover and simmer until eggplant is soft and title is absorbed. is soft and juice is absorbed.

Mushroom and Potato Curry

Quarter 6 small potatos or cut 4 medium or 2 large ones into 1 1/2" cubes. Wipe 1 1/2# mushrooms cle ones into 1 1/2" cubes. Wipe 1 1/2# mushrooms clean with a damp cloth. To maintain uniform size, cut larger ones in half or quarters. In 1/4 C hot oil, fry 1 bay leaf, 2 red chilis and 1/2 t white cumin seeds. When spices start to brown, add potatos and stir fry until a translucent shell forms on potatos. Add mushrooms and stir fry until they begin to soften and turn black. Stir in spices (1 1/2 t salt, 1 t coriander, 1 t cumin, 1/2 t turneric, and 1/4 t cayenne). Stir until all pieces are evenly coated with spices. with spices. Add water almost to cover and bring to a boil. Simmer covered about 15 minutes or until potato is done. Stir in 1 T ginee or sweet butter and 1/4 t ground sweet spices (cinnamon, cardamon seeds, and 1 clove—fresh ground if possible) mixed with a little milk. VARIATION: omit sweet spices and add 1 1/2 tomatos quartered along with the salt and basic 4 spices.

serve to have such a thing to worry about.



My wife and I visited her mom and dad over Labor Day weekend and they showed us your article about Sutter Buttes as a possible nuclear waste disposal site. To date only one letter has appeared in the paper in response to the article, and that was authored by my wife's mom, Mrs. Helen Liss.

Having read your report a number of times I've been struck by your excellent research, expressed in the best tradition of responsible journalism: fair, impartial with all the facts. But I am not writing as a journalist, and as you can see from the piece on the reverse side of this letter (Anna Lynn's article, "Past and Future History and the Perils of Nuclear Power"), I am definitely partial. I would even go so far as to say I'm informed!

Which is why I am writing to you. I'm hoping you can

help me with some more information. You quote Mr. Baietti as saying, "It is so preliminary I wouldn't want anyone to think we are actually considering it." Then you go on to point out that over eight months ago, on Jan. 3, tate officials received a one and one half page letter from ICN asking that the company be allowed to develop a site some where in the State. Not until the latter part of August do we find out that three sites have been examined closely and the Sutter Buttes is considered the best of the three. If that's not active consideration, I don't know what is! You go on to reveal that the only reason the public found out about it was because the State Senate killed a moratorium bill, supported by the State Department of Health, that would have suspended all site development activity util two Federal agencies, the Environmental Health Agency and the Nuclear Regulatory Commission, complete their current studies to determine what type of criteria

should be applied to nuclear disposal sites.

Something is fishy in Sacramento! The feeblest intelligence can perceive the wisdom of a moratorium until the EPA and NRC conclude their studies.

Could you help me in this way? Given the Freedom of Information Act, I thought you might have a copy of the one and one half page letter that International and Chemical Irvine sent to State officials on Jan. 3. And is there a chairman of a Senate Committee that recommended voting against the bill?

One other thing. Since there seems to be a shortage of positive and healthy ideas of what to do with the abandoned Titan missile silos (a modern problem that in a world of agreement and understanding will challange many creative minds), may I pass on to you one idea a friend suggested? Use them as a methane digester. Put wet garbage in them. The garbage becomes fertilizer, the gas of decomposition is methane, which I understand has only one carbon molecule.

#### THE PRINCIPLE OF STARTING AND MAINTAINING A BUSINESS

- 1. See the NEED to act
- 2. Understand the BASIS for business is the collective mind
- 3. Remember the PURPOSE of business is to provide a service
- 4. Define the OBJECTIVES of the business
- 5. Identify the ELEMENTS needed to meet the objectives
- 6. Develop a PLAN to meet the objectives
- 7. Identify the ELEMENTS needed to implement the plan
- 8. SECURE the elements
- 9. IMPLEMENT the plan
- 10. REVIEW the working plan and MODIFY as needed

#### I.THE BASIS

Aspiring to acheive the collective mind through a feeling of mutual love and self respect, forms the basis for the activity of business.

The collective mind or the union of two or more minds, stems from a feeling of agreement and understanding which comes from an applied feeling of love and self respect. This collective mind is the very core of life of a business. Without this unity the activity of business is limited by fragmented individualized egos.

With this unity the activity becomes an instrument of the creator and is limited only by time.

(A) Everyone involved in the business must be consciously aware of the value and importance of the

- collective mind and agree to aspire to strive for its achievement within the business.
- (B) Everyone involved in the business should always agree on the PURPOSE and the OBJECTIVES of the business; as well as the PLAN to meet the objectives, the way the plan is IMPLEMENTED, and should take part in the REVIEW and MODIFICATION of the working activities of the business.

The purpose of business is to provide a service. It is the reason for the activity. This purpose should always be the goal and end result of all business activity and should be impregnated into all activities of the business. Everyone involved should have the feeling of providing a service and also the feeling of being served.

#### III. LANGUAGE

To expect agreement within a business, the purpose, the objectives, and the plan of the business must be understood and communicated very clearly and constantly.

- (A) Everyone involved should clearly understand what he is expected to do and should clearly communicate what he expects others to do.
- (B) All areas of responsibility must be clearly identified and defined in terms of the quality and
- quantity of work to be performed within each area.

  (C) The best forum for this clarity is through regular meetings for the purpose of achieving the collective mind through communication.

#### III. ORGANIZATION

Cetting Started

Once the basis and purpose are established the rest is formal materialization. Simply stated-decide what

- you want to do, what it takes to do it, do it, and evaluate what you did.

  (A) The best way to begin the formal materialization is to take one step at a time, materialize the idea in writing, evaluate it and clarify it until it is perfectly clear and agreed upon, then go on to the next step.
- Finances- The above being done, all sound business then begins with establishing a six-month budget, estimating the amount of money you expect to spend versus the amount of money you expect to receive every month for the next six months. This should be done very thoroughly and without haste. When this is done you should know how much goods or how much services you must sell to support the everyday expenses of the you should know how much goods or now much services you must sell to support the everyday expenses or the business and produce a profit after all materials and expenses are paid. If you have to borrow money to get started, remember that loans are paid back out of net profits— what is left after all expected and unexpected material costs and expenses are paid. To borrow efectively you should have a very clear, specific plan to repay the loan on time as promised, which will establish trust with your creditors, who will very likely lend you more money in the future.

Maintaining a Business

What really maintains a business is the continuing need of the service being provided and the continuing aspiration to provide the service by the individuals involved. The people involved have to believe and have faith in what they are doing and not give up their faith when confronted with apparant obstacles. Everyone should agree to provide whatever energy it takes to materialize the agreed-upon imagination and demonstrate that agreement through action. With the basis and purpose established, constant application of will is the main ingredient to a successful business.

- (A) Financial Controls as with starting a business, maintaining a sound business begins with a monthly budget of expenses and income. An adequate record needs to be kept on all incoming bills to insure their prompt payment. At the end of the month the actual amount of income and the actual amount of expenses need to be compared to the budgeted amount and any differences need to be analysed and understood. This accounting (for income and expenses) provides a business with clear, factual information from which the business is able to budget or estimate more effectively in the future.
- (B) Problems Every business has apparant problems. Without apparant problems business would become so boring it would cease to exist. All problems should be addressed separately, squarely and honestly; the cause should be identified, agreement should be reached on a solution, and the solution should be implemented. It is very important to follow through with the agreed-upon solution. Then evaluate the effectiveness of the agreed-upon solution and act accordingly. The main thing to remember about problems is that they should be approached with the belief that they can be solved. (B)

Apparant problems create the need for communication which enables the collective mind to be perfected.
